## 40<sup>th</sup> Reunion



Reunion Chair **Al Keiller** and Co-Chair **Roger Brett** have been busy setting up a schedule and venues for the 40<sup>th</sup> Reunion, May 26-29. All Classmates should mark their calendars for next Memorial Day Weekend, May 26 – 29, 2006, and plan to attend this special Reunion. Al and Roger say there will be a large variety of activities, great meals, some special surprises, and lots of time to socialize with classmates. The weekend will begin with an opening reception and casual dinner in Collis (aka College Hall) on Friday evening, followed by continuing refreshments and socializing at the Hayward Lounge in the Inn. ### **Class Officers Weekend**

The College held its annual Class Officers Meeting on September 23 and 24 in Hanover. The purpose of the meeting is to train officers and give them the opportunity to share ideas with other classes and gain an understanding of new College programs and initiatives. **Bill Higgins, Steve Warhover, Chuck Sherman, Al Keiller, Bob Spence**, and I all attended.

Among the topics discussed, the group received updates on the new alumni constitution (see “Campus News” below), The Campaign for the Dartmouth Experience, and on-campus news from President Wright. Trustee Jose Fernandez ’77 gave an excellent talk on the Board of Trustees’ activities, including studies of alumni relations (e.g. alumni apathy), academic issues affecting the student body and faculty (e.g. class size, attendance restrictions on certain courses), the planning and construction of new student housing, and the increased funding of the Dartmouth Alumni Magazine, which will provide subscriptions to all alumni who have either attended a reunion, paid class dues, or given to the Dartmouth College Fund at least once over the last ten years. We also heard from David Spaulding ’76, the new Vice-President of Alumni Relations, who outlined his plans for his first months in office.

The Treasurers were exposed to an opportunity for each class to utilize on-line dues payment. The final session of the meeting focused on particular issues facing classes of the same decade; for our group (1966-75), the major discussion revolved around falling class participation rates, communication, improved reunion scheduling (e.g. weekends vs. mid-week, grouped vs. solo), and expanded class activities. The weekend finished with a very pleasant evening and dinner hosted by

Chuck Sherman and Margie Carpenter at their home in Strafford, VT, joined by John Hughes and Tim Urban from the rugby contingent.

Jim notes that the 2005-2006 dues solicitation will be going out shortly. ### **Dartmouth Athletic Sponsor's Program**

Speaking of the Dartmouth Athletic Sponsors, the DCAC recently released the results of the 2004-2005 program. Over \$300,000 was raised from classes (such as 1966) and individuals, which helped pay for 307 trips by student athletes to the campus. Of those 307 potential recruits, 42% ended up enrolling at the College, representing twenty-four men's and women's teams. ## Campus News

At the annual meeting of the Association of Dartmouth Alumni, on October 23, the slate proposed by the Association, which included **Stan Colla** as Secretary-Treasurer, defeated an alternative slate, led by **Dean Spatz**, 248-140. Under current rules, only those alumni physically in attendance at the meeting can vote. The incoming President, Allen Collins '53, pledged to move quickly on ratifying a new constitution, which, among other aspects, would open all future voting to electronic media and the mail, and strive to make the current Alumni Council more representative of the alumni body, with each class receiving one rep (it is now one for every two classes) and opening the election of at-large members to all alumni. The meeting lasted well over four hours as the candidacies of the two slates and the new constitution were debated.

On December 5, at 8 PM, the Alumni Council and Public Affairs will sponsor a Webcast on undergraduate education at Dartmouth. Trustee Al Mulley '70 will moderate the interactive live webcast, joined by Dean of Faculty Carol Folt and Alumni Council President Rick Routhier '73. Some classmates may not be familiar with the Dartmouth Continuing Education Office in Alumni Relations, headed up by Roberta Moore, who is ably assisted by Chris Coleman. Besides responsibility for on-campus continuing education programs, including the popular Saturday "Chalk Talks" before home football games, and programs sponsored by Dartmouth metropolitan and regional alumni clubs, the Office also works with outside travel agents to organize trips for alumni, both within the US and abroad. Besides the companionship of fellow Dartmouth alumni, these trips also include members of the Dartmouth faculty, who conduct lectures on such topics as the history, culture, language, geography, and geology of the places visited. Over the last six years, Karen and I have personally gone on two trips, to China and the Greek Islands, and have signed up for a trip to Southern Africa in May.
