A Letter from Chuck Sherman

Dear Class of 1966,

First off, I want to thank the many of you who have sent me words of support for the Class of 1966 Lodge, our biggest gift to the College since graduation. Jim Lustenader has just finished his first "official" solicitation letter which you should be receiving shortly. To quote from Jim's letter, "The funds for construction came from the DOC coffers, so we will be replacing those monies with our donation of \$160,000 in return for their naming the building *Class of 1966 Lodge*. Similar to many campus organizations – crew, football, swimming and others – the DOC does not receive much funding from the College and relies heavily on alumni support. So by helping the DOC, we are not only sponsoring a significant structure that people will enjoy for years to come with our Class in mind, but also supporting one of the most historic and vital organizations at Dartmouth. Donations to the Lodge are restricted, which means that they will go directly to the DOC. There are four donation tiers:

- John S. Dickey: \$10,000 and up
- Fred Harris: \$5,000-9,999
- Ross McKenney: \$1,000-4,999
- John Ledyard: up to \$999

Names of donors to the Lodge will be listed by tier on the class website and in the newsletter. And the names of all classmates who contribute, regardless of tier, will appear alphabetically on a plaque to be placed in the Lodge, making all donors part of this piece of the Dartmouth experience for generations to come. We want to get the campaign for the Lodge off to a fast start, so we are seeking as many cash donations and pledges as possible by Homecoming Weekend next year, which is also the 100th anniversary of the DOC's founding by Fred Harris. Once made, pledges will need to be paid by our 45th reunion in 2011; if you wish to pledge, you have up to three years to fulfill your commitment, which can be paid in installments over that time." A contribution form is located below; I hope you will consider a pledge or cash donation to this important project.

Second, I want to let you know that **Jim Lustenader** is taking over for **Terry Lowd** as Mini-Reunion Chair. Terry has had to devote extraordinary time to his new ship building and maintenance firm. I thank Terry for his two years of service to the class, running our annual Homecoming mini-reunions, and getting the planning for our 65th Birthday party in Santa Fe off to such a good start.

Jim is an energetic retiree and has agreed to take this on along with his responsibilities in support of the Class of 1966 Lodge. He has spent time in the Upper Valley this summer and has put together an excellent schedule for Homecoming. Thanks, Jim, for pitching in!

I look forward to seeing many of you at Homecoming (be sure to get your forms into Jim via Terry) and the inauguration of our beautiful new lodge.

Planning Continues for 65th Birthday Party

The Planning Committee with Mini-Reunion Chair **Jim Lustenader** at the helm has held two conference calls over the past two weeks to finalize the schedule for the Class 65th Birthday Party, May 22-25 in Santa Fe.

Activities and Events

Activities will start on Friday night, May 22, with a reception in La Terraza at the La Fonda Hotel. Dinner that evening will be on an individual basis: "block" reservations will be made at a number of nearby restaurants.

Saturday will include a variety of local activities, including visits to the Georgia O'Keefe Museum, the Folk Art Museum, the State Capitol, and a botanical tour. **Eric Treisman**, Rebecca and **Mike Bromley**, and Margie Carpenter will be leading groups of classmates on these various activities. Golf tee-times and tennis courts will also be available at the Black Mesa Golf Club and Bishop's Resort respectively. Saturday evening we will convene at the historic St. Francis Hotel (since 1880 on the Plaza) for reception, dinner, and talk by world-renown author Tony Hillerman. For those interested, Sunday we will tour some of the beautiful environs, including a visit to Anasazi ruins at Bandelier National Monument, a stop at the Los Alamos Science Museum, and a barbeque at a scenic location in the Carson National Forest. Sunday evening will be free for individual or group dinners. The 65th Birthday Party will conclude with a Monday brunch in the La Fonda Hotel's La Terraza overlooking Santa Fe's Plaza.



Accommodations

The La Fonda Hotel on the Plaza will serve as the "headquarters" hotel; a block of 30 rooms is available at \$189 per night for the weekend, a considerable savings from their regular rate. For those arriving earlier or staying later, additional nights at \$189 can be reserved on a "rooms available" basis. Call 800-523-5002 and mention "Dartmouth Class of 1966 Birthday Party".

The Committee has also reserved a block of 20 rooms at Garrett's Desert Inn for \$89 (queen bed) and \$99 (2 queen beds or 1 king). This hotel is approximately two blocks from La Fonda. Reservations should be made at 800-888-2145. Again, be sure to mention "Dartmouth Class of 1966 Birthday Party" to obtain the group rates. Additional nights at these prices can also be reserved "as available".

Transportation to Santa Fe

Airlines that fly into Albuquerque include Southwest, Northwest/Delta, United, Continental, American, USAir, ExpressJet, and Frontier. Because of Southwest, fares are fairly reasonable, if you're close to a

Southwest departure airport. "Sunport" Airport is about an hour's drive from Santa Fe.

Please remember **Bill Ramos'** offer: "I will fly in my Cessna 414 any & all '66ers & family from Albuquerque to Santa Fe and back. The 43 nautical mile flight should take about 16 minutes (add in taxi and climb out time it will be closer to 25 min). I can take up to 6 people per trip (NOT counting myself) in twin-engine, pressurized, air conditioned comfort." News from Classmates

Gary Broughton writes, "I have been busy since late March serving on a panel that conducted an independent safety evaluation of the Indian Point nuclear station. It promised to be a unique and challenging opportunity or I would not have given up four months of retirement to do it. Fortunately it was all I expected and more. Hopefully the report [public, available at www.nyindianpoint.org] will be useful to the plant owners, public officials and local citizens." As many of you know, Gary spent time during his career in electricity generation, managing Three Mile Island in PA. Gary, who has previously biked west-to-east across the entire country, will also be participating in a north-to-south Maine to Florida Bike Trip during September and October.

Rob Cleary has written a short piece ([Dartmouth Green Called to Duty](#)) regarding his experience with three other Dartmouth graduates (**Greg Eden**, Bill Nickerson '64 and Rob Peacock '68) flying A-6 Intruders, planes "designed to fly primarily at night and capable of low-level, target acquisition in all weather conditions. It was a demanding aircraft to fly because of its technical components, but once learned, the A-6 proved to be one of the military's most effective aircraft in Vietnam." Rob submitted the article to the *Dartmouth Alumni Magazine* in June and is awaiting word of publication; he notes that Bill Nickerson and Rob Peacock gave the ultimate sacrifice and are honored at the Vietnam Memorial in Washington, DC.



Bob Page sent an article on his company, DPK Consulting, an international justice administration firm, published by the San Francisco Daily Journal, a daily law journal. The article recounts how Bob and partner Bill Davis, after careers in domestic judicial administration, founded the \$16 million (revenue) company in 1993. With 130 staff members worldwide, the company has projects in 20 countries, with clients including USAID and the World Bank. Often competing with non-profit organizations and individuals, the article notes that Bob and his partner have the advantage

of extensive experience in the field and have developed “real in-house expertise”. Bob and Bill met in Latin America during stints with the Peace Corps. With masters degrees in regional planning from UNC and public administration from Harvard’s Kennedy School, Bob’s career before DPK included senior positions at the US District Court in the Southern District of NY and the City of New York Department of Sanitation. A bachelor until a few years ago, Bob and wife Grace now have an 18 month old son Nathaniel (see December 2007 *Along Route ’66*), our youngest Class of 1966 child.

Jim Cason, the now former (since August 2) US Ambassador to Paraguay, has become a music sensation in the country after recording an album of folk songs in the indigenous Guarani language. As reported by NPR and the BBC, Jim stated, “What I’ve been trying to do is show respect for Paraguay and for its culture. The polls show that Paraguayans thought we didn’t respect their culture. I said, that’s not true and so that’s why before I even came to the country, I learned Guarani and I’ve been studying since then. I’ve never been to a country where I can’t speak the language.”



Through his lessons, he discovered that Paraguay “has really beautiful music”, he said. Never involved in professional music before, Jim was encouraged to sing by Paraguay’s most celebrated soprano, Rebecca Arramendi. Appearances on radio, television, and at concerts followed, including a sold-out performance in June at Paraguay’s premier concert theater, and the recording of a CD of folk songs, including one the ambassador wrote himself, “Campo Jurado”. Some reviews have been less than favourable, and one Paraguayan politician said the ambassador “sings horribly and his pronunciation of Guarani words is stammering”. But listeners have been enthusiastic and the government of Paraguay has recognized Jim’s contributions to Paraguayan culture by decorating him with their highest cultural award, the National Order of Merit, Don Jose Falcon, the first foreigner to ever have received it!. “I think they’re just amazed and delighted that someone would take the time to learn a language which is probably harder than Chinese,” he said.

Proceeds from the album sales are going to fund English-language scholarships at the Paraguayan-American Cultural Center.
