Letter from the *Yacht Courier*, July 6, 1984. 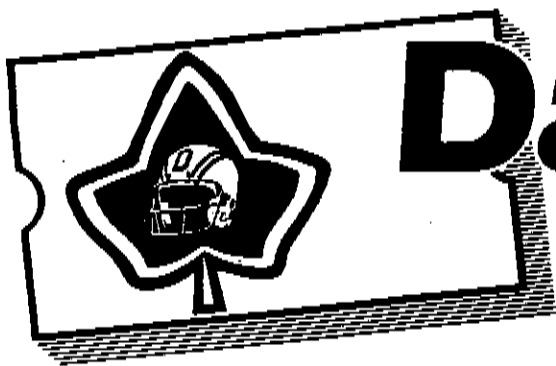

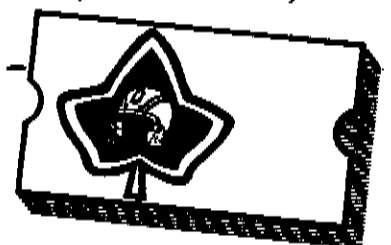
