Howie Weiner has published another book (look for them all on Amazon.com) on Multiple Sclerosis entitled Curing MS: How Science is Solving the Mysteries of Multiple Sclerosis.

Chuck Sherman was kind enough to pass along a brief review from Science News (according to Chuck a “weekly”, read “weakly”):

“Weiner’s documentation of this 30-year-long quest to find the cause of multiple sclerosis (MS) pinpoints a treatment, and discovers a cure is not only a poignant examination of the research being conducted regarding this particular disease, but also a solid overview of the nature of medical research in general. Affiliated with Harvard Medical School and Brigham and Women’s Hospital, Weiner has been in on the development of the most cutting-edge therapies for the disease. In these pages, he offers clear background about how scientists now understand the nature of MS in spite of the myriad ways in which the disease affects different people. Among the valuable research tools that Weiner highlights as particularly valuable in pushing forward MS research is magnetic resonance imaging. He provides a 21-point hypothesis on the cause and treatments of the disease that includes details of how those treatments work, in clear language. Weiner explains the field’s major discoveries and describes the challenges still looming. All of this is set against the background of how scientists work together, or sometimes don’t, and the role that business, especially the pharmaceutical industry, plays in the scope and character of MS research.”

The book is published by Crown at \$24.95. Chuck adds that Howie has received substantial research support from the National Institutes of Health over the years.

Also in the area of publishing and books, **Bob Cohn** writes, "My company, Times-Mirror Magazines, was sold to AOL-Time Warner in 2001. Working with my former CEO and a private equity group in Chicago, we have created a new 'boutique' media firm called Active Interest Media. Dartmouth College Fund Report

Bob Spence and his team of Assistant Class Agents did an outstanding job in helping the College raise a total of \$31.4 million with a 47.4% participation rate. We were one of 26 classes to set a new non-reunion year record. I have reprinted Bob's email sent to the Class in August:

Dear Classmate,

I am pleased to announce that the Class of 1966 set a new Dartmouth College Fund non-reunion year record, with a total of \$239,212 contributed vs. a goal of \$200,000. Our participation rate of 45.8% was below our goal of 48% and something I hope to focus on even more next year. Our total dollars represented a 25% increase vs. last year. While thanks are in order to everyone who contributed, I wish to express a special thanks to the many classmates who assisted in this effort as assistant class agents. I am hoping that all of you will consider helping again next year. Anyone who would like to volunteer as an assistant agent, please let me know by return email.

The Fund in total raised \$31,452,315, a new record, with a participation rate of 47.4%, a 2 percentage point increase over 2003.

Hope everyone is having a pleasant summer and look forward to seeing many of you in October.

Dartmouth Athletic Sponsor Program

As you know, a portion of our Class dues goes to the support of recruiting student athletes to Dartmouth. This past year \$305,000 was raised from individuals and classes. Our \$1,000 contribution puts us in the Top Ten of classes. Among the sports that recruited successful high school athletes as a result of the program were men's football, hockey, basketball, lacrosse, soccer, swimming, baseball, cross country, rowing and tennis and women's basketball, soccer, ice hockey, field hockey, swimming, volleyball, track, lacrosse, and softball.

Class Financial Report

Each summer, **Jim Weiskopf** as Class Treasurer submits a summary of the class' finances for the past fiscal year. During 2003/2004, 386 classmates paid their \$40 dues and 372 contributed an additional \$10 for the JSD Foundation fellowships, the same as last year. Total receipts, including mini-reunion income, totaled \$19,806 and total expenses, including alumni magazine subscriptions, our contributions to the fellowships and Dartmouth Sponsors, plus expenses for the two mini-reunions, totaled \$19,798, for a surplus of \$8! Well done, Jim!

In Memorium

We join the College in mourning the death of David T. McLaughlin, Dartmouth's 14th President, on August 25 at age 72. Mr. McLaughlin, AB '54, Tuck '55, the last alumnus to serve the College as president (1981 to 1987), had been CEO of Toro Manufacturing prior to becoming Dartmouth's President. He had previously been involved with the College as a member of the Board of Trustees from 1971 and as its Chairman from 1977 until he succeeded John Kemeny.
